

POLICY STATEMENT

This policy statement applies to all activities and processes of P&V Panels.

- 1. P&V Panels strives to implement continuous improvements in quality, safety, health, the environment and energy performance. In doing so, P&V Panels aims to achieve optimal satisfaction on the part of all stakeholders. For this reason,
- have set high standards for quality, safety, health, the environment and energy;
